

“KMG5 Sweepstakes” Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Sponsor

The KAIDO Motors “KMG5 Sweepstakes” (“Sweepstakes”) is organized, sponsored, and fully managed by Kaido Motors LLC, located at 2524 N Broadway Ste 554 PMB 418658 Edmond, Oklahoma 73034 (referred to herein as the “Sponsor”).

KAIDO Motors is the sole and exclusive sponsor of this event, and all aspects of the sweepstakes from entry, administration, prize distribution, and compliance fall under its oversight. The Sponsor assumes full responsibility for maintaining fairness, transparency, and compliance with all applicable laws.

Throughout this document, any mention of “Sponsor” or “KAIDO Motors” refers to the same entity. The Sponsor’s decision in all matters regarding the sweepstakes, including eligibility, timing, and interpretation of rules, is final and binding in every respect.

2. Eligibility

The Sweepstakes is open only to individuals who are **legal residents of the contiguous United States** and the District of Columbia, and who are **18 years of age or older** as of the **date of entry**.

Residents of Alaska, New York, Florida, Rhode Island, Hawaii, and Puerto Rico are not eligible to participate due to state and territory specific restrictions. Entries from those states or territories will not be accepted under any circumstance.

Employees, officers, directors, representatives, and agents of the Sponsor, its affiliates, subsidiaries, advertising or promotion agencies, and the immediate family members (spouse, parents, siblings, children) or any person residing in the same household as any of the above individuals, whether related or not, are ineligible to enter or win.

Participation in this Sweepstakes constitutes the entrant’s full and unconditional agreement to abide by these Official Rules and to accept the Sponsor’s decisions as final and binding. Any attempt to circumvent the rules, manipulate entries, or otherwise interfere with the fairness of this promotion will result in disqualification.

All applicable **federal, state, and local laws and regulations** apply. The Sweepstakes is void where prohibited, restricted, or regulated in a manner inconsistent with these Official Rules.

3. Sweepstakes Period

The Sweepstakes begins at 4:00 p.m. Eastern Time (ET) on May 7, 2026, and ends at 11:59 p.m. ET on June 15, 2026 (the “Sweepstakes Period”).

Entries submitted before or after these times will not be accepted. Sponsor’s computer system serves as the **official clock** for the Sweepstakes. The Sponsor retains exclusive authority to determine when the Sweepstakes begins, ends, and how entries are logged.

Entrants are encouraged to submit entries early in the Sweepstakes Period to avoid any technical or timing issues. Once the deadline passes, no additional entries will be accepted, regardless of reason or circumstance.

4. How to Enter

There are **two primary methods** to enter the Sweepstakes, both designed to ensure fairness and accessibility for all eligible participants.

(a) Automatic Entry with Purchase

Eligible individuals who make a qualifying purchase from the Sponsor during the Sweepstakes Period will automatically receive two hundred (200) entries for every one dollar (\$1.00 USD) spent on qualifying purchases from the Sponsor. The qualifying items, amounts, and promotional details are listed on the official KAIDO Motors website at <https://kaidomotors.com>.

Each completed purchase during the active Sweepstakes Period grants automatic entries, and all such entries are tied to the purchaser’s verified contact information. Purchases made outside of an active Sweepstakes Period will be held in a queue and automatically applied to the next available Sweepstakes upon its activation.

(b) Free Entry Without Purchase

To ensure fairness and comply with federal sweepstakes laws, eligible individuals may also enter **without making a purchase**. Participants may complete the **free entry form** available on the Sponsor’s website during the Sweepstakes Period.

Free entries are limited to one (1) free entry claim per person per day, with a twenty-four (24) hour cooldown between claims. Each free entry claim awards two hundred (200) entries into the Sweepstakes. Any attempt to exceed these limits through multiple accounts, names, or automated systems will result in disqualification.

All entries, whether submitted through purchase or the free form, become the **property of the Sponsor** and will not be acknowledged or returned. The Sponsor will not accept entries

generated by bots, macros, scripts, or other automated devices. Any such attempt will void all associated entries.

Participation constitutes consent to be contacted by KAIDO Motors regarding Sweepstakes administration, prize delivery, and related updates.

5. Prize

There will be one (1) Grand Prize Winner, selected in accordance with these Official Rules.

The Grand Prize consists of:

- **One (1) 1995 Mitsubishi 3000GT VR-4, 6-Speed Manual, Pearl White, twin turbo, all wheel drive, with approximately 120,000 miles, clean U.S. title, Active Aero Wing, MonoRS coilovers, RoboModded glass headlights, and Merceli M41 wheels.**

The total Approximate Retail Value (ARV) of this prize is \$15,000 USD.

The Grand Prize is awarded “as is,” with no warranty, guarantee, or representation, either express or implied, except as required by law. The Sponsor is not responsible for any mechanical issues, cosmetic conditions, or performance aspects once the vehicle is transferred to the winner.

The Sponsor makes no representations regarding street legality, emissions compliance, or suitability for daily driving.

The winner is solely responsible for all associated expenses, including but not limited to federal and state taxes, vehicle title, license, registration, and insurance.

The Sponsor will cover reasonable transportation of the prize vehicle to the winner within the contiguous United States.

No substitution, cash alternative, or transfer of prize will be permitted, except at the Sponsor’s sole discretion. In the unlikely event the described prize becomes unavailable for any reason, the Sponsor reserves the right to award a prize of equal or greater value.

6. Winner Selection and Odds

At the conclusion of the Sweepstakes Period, one (1) potential winner will be chosen through a **random drawing** conducted from all eligible entries received. The drawing will take place **within approximately seven (7) days** after the Sweepstakes end date.

The odds of winning depend solely on the total number of eligible entries received during the Sweepstakes Period. Every valid entry has an equal and fair chance of selection.

The Sponsor will use reasonable methods to ensure the drawing is conducted securely, fairly, and in full compliance with applicable regulations.

7. Winner Notification and Requirements

The potential winner will be contacted by **email and/or phone** within approximately **five (5) business days** after the random drawing.

The selected entrant must promptly complete, sign, and return all required documentation, including an **Affidavit of Eligibility**, a **Liability/Publicity Release**, and an **IRS Form W-9**.

Note: The Affidavit sent to a potential Winner will require that the Winner provide their Social Security Number to the Administrator, which will be used solely for tax reporting purposes. These documents must be received by the Sponsor within **seven (7) days** of notification.

The winner acknowledges that the prize vehicle is a modified vehicle and understands that operation and ownership of such a vehicle involves inherent risks. The winner voluntarily assumes all risks associated with operation and ownership of the vehicle after delivery. Risk of loss transfers to the winner upon delivery of the vehicle.

If the potential winner fails to respond, submit the required paperwork, or is found to be ineligible, the Sponsor reserves the right to select an alternate winner from the remaining eligible entries.

Once verified, the Sponsor will coordinate directly with the winner to arrange delivery or pickup of the prize, along with any necessary tax documentation.

8. Taxes

All taxes, whether federal, state, or local, that may be associated with accepting or using the prize are the **sole responsibility** of the winner.

The Sponsor will issue an **IRS Form 1099** reflecting the total value of the prize as required by law. The winner should consult a qualified tax professional for advice regarding their individual obligations.

Failure to comply with tax requirements may affect eligibility or delay prize fulfillment.

9. General Conditions

The Sponsor reserves the right to disqualify any entrant found to be tampering with the entry process, violating these Official Rules, or acting in a disruptive or unsportsmanlike manner.

If, for any reason, the Sweepstakes cannot operate as planned, including but not limited to technical malfunctions, fraud, human error, or other circumstances beyond the Sponsor's control. The Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes in whole or in part.

Should the Sweepstakes be canceled prior to the conclusion of the advertised period, the Sponsor may, at its discretion, conduct a drawing from among all eligible entries received up to the time of termination.

By entering, participants agree that all decisions made by KAIDO Motors regarding eligibility, compliance, and prize award are final and binding.

10. Release and Limitation of Liability

By participating, entrants agree to **release and hold harmless** the Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and all respective officers, directors, employees, and agents from any claim or cause of action arising from participation in the Sweepstakes or the receipt or use of any prize.

This includes but is not limited to any personal injury, property damage, or loss of any kind, whether directly or indirectly caused by participation in the Sweepstakes or by the use or acceptance of the prize.

Entrants assume all risk related to participation. The Sponsor shall not be held liable for any errors, technical failures, or interruptions that may affect the operation of the Sweepstakes.

11. Publicity

By accepting the prize, the winner grants the Sponsor full and unrestricted permission to use their **name, likeness, voice, city, and state of residence** in promotional materials, advertising, and public announcements, without additional payment or approval, unless prohibited by law.

This release applies to all media, including print, broadcast, and digital platforms, and is intended to allow the Sponsor to share the excitement and authenticity of the promotion with the public.

12. Governing Law

All issues, disputes, or questions regarding the construction, validity, interpretation, or enforceability of these Official Rules, or the rights and obligations of the entrants and Sponsor, shall be governed by the **laws of the State of Oklahoma** without regard to conflict-of-law principles.

Any legal proceedings arising under or related to this Sweepstakes shall be brought exclusively in **Oklahoma County, Oklahoma**. By entering, each participant expressly agrees to submit to such jurisdiction and venue.

13. Privacy

Information collected from participants will be handled in accordance with the Sponsor's **Privacy Policy**, available at <https://kaidomotors.com/policies/privacy-policy>.

By participating, entrants consent to the collection and use of their personal information by the Sponsor for purposes of administering the Sweepstakes, verifying eligibility, and fulfilling prizes.

Entrants who opt in may receive future promotional messages from KAIDO Motors, though participation in this Sweepstakes is not conditioned on such consent.
